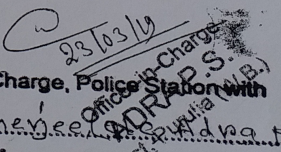

Sir,

In producing here with one arrested accused namely Tarapada Baskey (49 Yrs) S/O Lt. Bodi baskey of Vill- Kantaranguni, PS-Adra, Dist- Purulia along with following seized articles viz-

- 1) 20 bottles (in sealed condition) DIL Khush country spirit, 600-ml each bottle and Rs-35 of each bottle.
- 2) Seven pieces of plastic glasses.

I ASI Rajkumar Goswami of Adra PS do here by lodged a complaint against accused namely Tarapada Baskey (49 Yrs) S/O Lt. Bodi baskey of Vill- Kantaranguni, PS-Adra, Dist- Purulia to the effect that on 23.03.19 at about 16:45 hrs. in course of my evening mobile duty I received a telephonic information from a reliable source that one Tarapada Baskey was stocked of country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per his direction I along with force. At about 17:05 hrs. I along with force reached at Kantaranguni and hold raid in the house of Tarapada Baskey found that said of Tarapada Baskey selling liquor at his own house and seeing the Police party some person fled away and said of Tarapada Baskey to concealed himself but I able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accused Tarapada Baskey (49 Yrs) S/O Lt. Bodi baskey of Vill- Kantaranguni, PS-Adra, Dist- Purulia and arrenge for its investigation.
