I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accused Tarapada Baskey (49 Yrs) S/O Lt. Bodi baskey of Vill- Kantaranguni, PS-Adra, Dist- Purulia and arrenge for its investigation.
