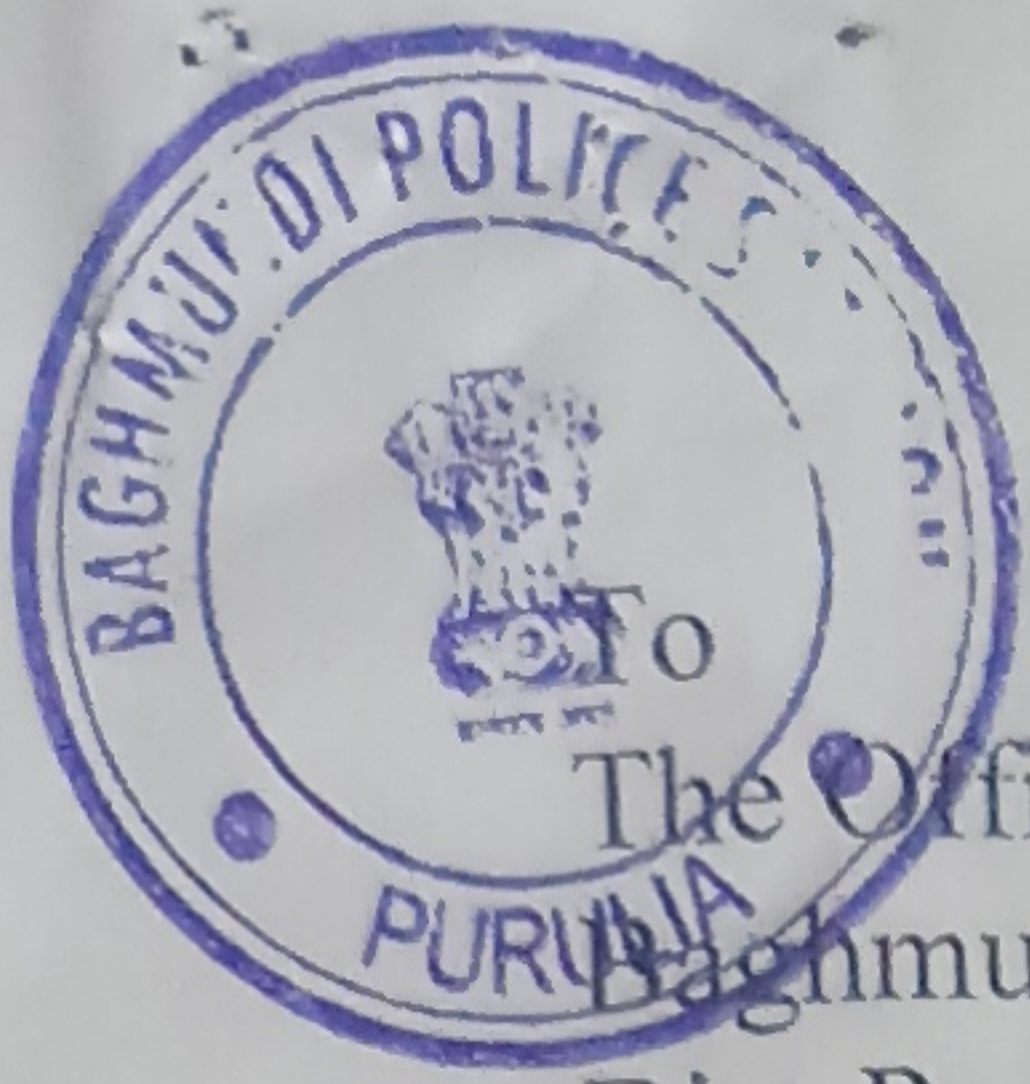

Respected Sir,

In producing herewith arrested accused namely Bhola Chowdhari (40 yrs), S/O-Lt- Mohabir Chowdhary of village Gosaidhii Dist- Purulia along with seized articles, I beg to report that on 11.03.19 in course of mobile duty myself along with force got reliable source information that one person is selling liquor at village Gosaidhi in his house. Accordingly myself along with 1. C/1319 Soumen Koley, 2. C/564 Prasad Majhi, all of Baghmundi P.S reached at Gosaidhi village in the house of above noted person at about 17.25hrs and found that one person was selling. Liquor (Country Sprit) in his house. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document regarding selling liquor(Country Sprit). So the above noted accused has committed an offence U/S -46(A)(c) B.E. Act 1909 Amended up-to date. During search I found 1) 25(Twoenty Five) bottle country made 375ml "Dil Khush" , 2) 10 (Ten) bottle country made 600 ml) as "Dil Kush", (3)) 05 Empty bottle(Country Sprit) of DilKhush.(4) Rs 30/- as sale proceed (5) One sample bottle out of 35 bottle of country sprit the above noted articles seized under proper seizure list duly signed by the witnesses in between ^{17.35hr} 18.05 hrs. to ^{17.45} 18.15 hrs. I also seized and labeled bottles with sample liquor(Country Sprit)at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person U/S-67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with seized above noted articles.

Therefore I pray before you that kindly arrange to start a specific case U/S 46(A)(c) B.E. Act 1909 against arrested accd Bhola Chowdhari (40 yrs), S/O-Lt- Mohabir Chowdhary of Vill-Dehury, P.S.-Hasua, Dist-Nawda stats Bihar A/P C/o Thakurdas of village of Gosaidhii Dist- Purulia and arrange for its investigation.
