I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Sishir Kumar, S/O- Late Aghnu Kumar of village Bukadih, P.O- Burda, PS- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 12.03.2019 at about 12:40 p.m. I Sri Swapna Kumar Das, AE & Station Manager, Bagmundi CCC along with 1. Sri Sukhamoy Maji, SAE (E), Bagmudi CCC, WBSEDCL 2. Sri Shubhasis Mahato, OE, Bagmudi CCC, WBSEDCL, entered the premises of Sri Sishir Kumar, S/O- Late Aghnu Kumar of village Bukadih, P.O- Burda, PS- Bagmundi, Dist- Purulia and found Sri Sishir Kumar was enjoying electricity unauthorizedly, drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.20 KVA.

As Sri Sishir Kumar, S/O- Late Aghnu Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sukhamoy Maji, SAE (E), Bagmudi CCC, WBSEDCL 2. Sri Shubhasis Mahato, OE, Bagmudi CCC, WBSEDCL. The inspection team left the premises at 12:50 p.m.
