

Sir

In Forwarding herewith arrested accd person Falari Mahato (36),S/O-Prafulla Mahato of Vill-Kushaldih,PS-Baghmudi,Dist Purulia to your Ld.Court with proper Police escort along with all contacted papers .I beg to report that on 19.0319, at 18.05 hrs in course of Mobile Duty SI Pulok Bhattacharjee of Bagmudi PS received a telephonic information from his source over telephone that huge number of wine bottles are staged in the house of Falari Mahato (36),S/O-Prafulla Mahato of Vill-Kushaldih,PS-Baghmudi,Dist Purulia and the above noted persons was selling country-sprit in his respective House accordingly SI Pulok Bhattacharjee informed to O/C Bagmudi PS in this regard. As per direction of O/C Bagmudi PS SI Pulok Bhattacharjee along with force rushed to Kushaldih at the above noted said house to work out the information. At about 18.25 hrs he along with force reached at the spot and held raid in the above noted house and found that the some persons were assembled and consuming liquor inside and outside of the above noted house.

On seeing police party the assembled persons managed to flee away from the spot. On search there and found that the said person was selling the country spirit in his house. On demand he failed to produce any valid papers/ documents in support of selling country spirit in his respective house. As such he seized. 1) 23(Twenty Three) sealed bottle country made 375 ml "Dilkhus"2) 10(Ten) sealed bottle country made 600 ml. "Dilkhus" 3) 04(Four) empty bottle country sprite of Dilkush, 4) 01(One) sample bottle out of 23(Twenty Three) bottle of country sprite in presence of local witnesses from the possession of above noted arrested accd persons and duly signed by witnesses as well as the accd persons and also prepared label.As per endorsement of O/C Bagmudi PS I took up investigation of this Case.During investigation I have done the all formalitie for the preliminary part of investigation.

Therefore I pray before yours honors court that above noted accused person may kindly be taken in your JC till the investigation of the case

I strongly opposed the bail of the aforesaid accd persons for following reasons.

- 1) Investigation of this case is at its nascent stage.
- 2) He may abscond and go beyond the control of surety, hampering of the investigation of the case,
- 3) He may commit act of violence on the witnesses of this case in revenge.
- 4) He may released on bail local law and order problem is arise.
