On demand he failed to produce any valid papers/ documents in support of said country spirit. Further interrogation a said accused person stated that he transported the said country sprit for selling at Bagmundi Bazar. Accordingly I seized the said 28 bottles country sprit as per seizure list from the possession of above noted accd person duly singe by witnesses as well as accused person and also prepared label, I arrested the accused namely Sanju Choudhary (34) S/O- Lt- Murarilal Choudhary of Balarampur Tata road, PS- Balarampur, Dist- Purulia, provided arrest cum inspection memo and brought with PS, put into lock up after all formalities as per guide line of Hon'ble Apex Court.
