Respected Sir,

In producing here with one arrested accused person namely Chittaranjan Paramanik (32 yrs) S/o- Amulya Ratan Paramanik of Vill.- Khekridih, P.S.-Balarampur, Dist. Purulia along with seized 18 (eighteen) sealed country sprit bottles (DIL KHUS) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 17:45 hrs. I received a credible source information that one person namely Chittaranjan Paramanik S/o- Amulya Ratan Paramanik of Vill.- Khekridih, P.S.- Balarampur, Dist. Purulia is selling country sprit without any valid license from his own house/shop at Khekridih under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for Khekridih village to work out the source information and held raid in the house/shop of accused person.

During search with the help of accompany force, we found that the said person is selling country sprit bottles at his own shop. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of said country sprit. Accordingly, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled sample bottles. Total 11 (eleven) litters country sprit has been seized, total value of the said seized sprit is Rs-642/= (Six hundred forty two only) and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Chittaranjan Paramanik S/o- Amulya Ratan Paramanik of Vill.- Khekridih, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
