Respected Sir,

In producing here with one arrested accused person namely Rinku Sau (27 yrs) S/O- Gangadhar Sau of Vill.- Tata Road, P.S.- Balarampur, Dist. Purulia along with seized 1) 26 (twenty six) sealed country sprit bottles (DIL KHUS), 2) Empty DIL KHUS Bottle 15 Pieces (Each Bottle 600 ML X 26 bottle=11 liters approx) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 19:55 hrs. I received a credible source information that one Pan Gumti Shop owner of namely Rinku Sau in front Bharat Petroleum Pump beside NH-32 Tata Purulia Road is selling country sprit without any valid license from his own Pan Gumti Shop at Tata Road under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for Tata Road near Bharat Petroleum Pump to work out the source information. Thereafter we reached at in front of Bharat Petrol Pump at about 20:05 hrs and held raid in the Pan Gumti Shop of accused person.

During search with the help of accompany force, we found that the said person is selling country sprit bottles at his own Pan Gumti Shop. On demand, he failed to produce any valid documents & valid License in respect of selling and keeping of said country sprit but he failed produced the any valid documents. Accordingly, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled sample bottles. Total 1) 26 (twenty six) sealed country sprit bottles (DIL KHUS), 2) Empty DIL KHUS Bottle 15 Pieces (Each Bottle 600 ML X 26 bottle=11 liters approx and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Rinku Sau S/O- Gangadhar Sau of Vill.- Tata Road, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
