

In producing herewith arrested accused Ajit Singh Bhumij (48 yrs) S/O-Lt. Swarup Singh Bhumij of Vill.- Lakhandih, P.S. - Balarampur, Dist - Purulia and brought under seizure

1) One improvised iron made, country made pipe gun having length about 7 $\frac{1}{2}$ ", having iron But length about 3 $\frac{1}{2}$ ", having trigger, firing pin with one

live cartridge (unloaded).

2) One iron made, country made SBBL Gun having length about 40", having Wooden butt length about 12", having barrel length about 26", having trigger, firing pin loaded with one live cartridge.

3) One iron made, country made SBBL Gun having length about 42", having Wooden butt length about 11 $\frac{1}{2}$ ", having barrel length about 28", having

trigger, firing pin loaded with one live cartridge.

4) One iron made, country made SBBL Gun having length about 36 $\frac{1}{2}$ ", having Wooden butt length about 12", having barrel length about 26",

having trigger, firing pin loaded with one live cartridge.

5) One iron made, country made SBBL Gun having length about 39", having Wooden butt length about 12", having barrel length about 26", having trigger, firing pin, under proper seizure list duly signed by the witnesses as well as accused person. I do hereby lodge a complaint to the effect that in course of night mobile duty at 02:05 hrs. I received a telephonic information from my source that 02 (two) persons namely Ajit Singh Bhumij of Vill.-Lakhandih & Madhu Singh Sardar of Vill.- Tantidih get a contract for supplying arms & ammunition, and in this regard they will pass through Kurni more towards Ruchap village along with some arms & ammunition to supply the same on 13.03.19 at approx 03:30 hrs. Accordingly I informed the matter to O/C Balarampur P.S. over cell phone and as per direction of O/C Balarampur PS necessary re enforcement have been made. At 02:45 hrs. myself along with accompany force and officers along with source reached at Ruchap more with Govt. vehicle No. i) WB56B/4922 & ii) WB56D/9059 and kept the vehicle in a safe distance and proceeded towards Kurni More on foot and ambushed at Kurni more. At about 03:15 hrs we found 02 (two) persons coming from Kurni village side on pitch road. We tried to intercept them at Kurni more. But on seeing Police they try to fled away but on hot chase we able to apprehend one of them and another person fled away in darkness in Jungle. On being asked he disclosed his identity as Ajit Singh Bhumij (48 yrs) S/O- Lt. Swarup Singh Bhumij of Vill.- Lakhandih, P.S. - Balarampur, Dist -

Purulia and he also confessed the name of the another person who flee away as Madhu Singh Sardar S/O- Lt. Kandan Singh Sardar of Vill.- Tantidih, P.S.-Balarampur, Dist.-Purulia. On being searched we found the above noted arms & ammunition which is wrapped in a black polythin paper and kept inside a gunny bag which was carried on articles head. On through search on his person we found one improvised iron made pipe gun having length approx 7 1/2", having iron but trigger, firing pin found in his left waist, which is kept conceal in his pant. On being asked he failed to produce any valid license or authority for the said arms & ammunition which is found his possession or which arms & ammunition he carrying. So I seized the said arms & ammunition under proper seizure list duly signed by the witnesses as well as arrested him monitoring all the guide line regarding arrest. No public witnesses could be available there due to odd hours of night.

Under the above fact and circumstances, I therefore pray before you to start a specific case under proper section of law against 1) Ajit Singh Bhumij (48 yrs) S/O- Lt. Swarup Singh Bhumij of Vill.- Lakhandih, P.S. – Balarampur, Dist – Purulia & 2) Madhu Singh Sardar S/O- Lt. Kandan Singh Sardar of Vill.- Tantidih, P.S.- Balarampur, Dist.-Purulia and obliged.
