Respected Sir,

In producing here with one arrested accused person namely Mithun Saw (27) yrs) S/O- Thakur Saw of Vill.- Balarampur Tata Road near Petrol Pump, P.S.-Balarampur, Dist. Purulia along with seized 15 (fifteen) sealed country sprit bottles (DIL KHUS) (Each Bottle 600 ML X 15 bottle=9 liters) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 16:05 hrs. I received a credible source information that one House/Shop owner of Thakur Saw at Balarampur Tata Road Near Petrol Pump is selling country sprit without any valid license from his own House/Shop at Balarampur Tata Road Near Petrol Pump under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for Balarampur Tata Road Near Petrol Pump to work out the source information. Thereafter we reached at Balarampur Tata Road Near Petrol Pump at about 17:05 hrs and held raid in the House/Shop of accused person.

During search with the help of accompany force, we found that the said person is selling country sprit bottles at his House/Shop. On demand, he failed to produce any valid documents & valid License in respect of selling and keeping of said country sprit but he failed produced the any valid documents. Accordingly, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled sample bottles. Total 15 (fifteen) sealed country sprit bottles (DIL KHUS) (Each Bottle 600 ML X 15 bottle=9 liters) and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Mithun Saw S/O- Thakur Saw of Vill.- Balarampur Tata Road near Petrol Pump, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
