Respected Sir,

In producing here with one arrested accused person namely Yudhistir Ruhidas (45 yrs) S/O- Lt. Bahadur Ruhidas of Vill.- Kerowa, P.S.- Balarampur, Dist. Purulia along with seized 20 (twenty) sealed country sprit bottles (DIL KHUS) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 16:45 hrs. I received a credible source information that one person namely Yudhistir Ruhidas S/O- Lt. Bahadur Ruhidas of Vill.- Kerowa, P.S.- Balarampur, Dist. Purulia is selling country sprit without any valid license from his own house/shop at Kerowa under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for Kerowa village to work out the source information and held raid in the house/shop of accused person.

During search with the help of accompany force, we found that the said person is selling country sprit bottles at his own shop. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of said country sprit. Accordingly, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled sample bottles. Total 12 (twelve) litters country sprit has been seized, total value of the said seized sprit is Rs- 700/= (Seven hundred only) and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Yudhistir Ruhidas S/O- Lt. Bahadur Ruhidas of Vill.- Kerowa, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
