Respected Sir,

In producing here with one arrested accused person namely Jotal Mandi (56 yrs) S/O- Lt. Naike Mandi of Vill.- Soldih, P.S.- Balarampur, Dist. Purulia along with seized approx 25 liters Illicit Liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 18:05 hrs. I received a credible source information that one Jotal Mandi S/O- Lt. Naike Mandi of Vill.-Soldih, P.S.- Balarampur, Dist. Purulia is selling Illicit Liquor without any valid license from his own House at Soldih under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for Soldih to work out the source information. Thereafter we reached at Soldih at about 18:35 hrs and held raid in the house of accused person.

During search with the help of accompany force, we found that the said person is selling Illicit Liquor at his House. On demand, he failed to produce any valid documents & valid License in respect of selling and keeping of said Illicit Liquor. Accordingly, I seized approx 25 liters Illicit Liquor kept in 02 plastic Jaricanes after preparing proper seizure list duly signed by the witnesses and labelled the sample which took from the seized Illicit Liquor kept in the 02 Plastic Jaricanes and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Jotal Mandi (56 yrs) S/O- Lt. Naike Mandi of Vill.- Soldih, P.S.-Balarampur, Dist. Purulia and arrange for its investigation.
