In producing here with 03 (three) arrested accused persons namely 1) Rathu Singh Sardar (38 yrs) S/O- Paban Singh Sardar, 2) Somchand Soren (23 yrs) S/O- Lt. Kalipada Soren both of Vill.- Barachatarma, P.O.- Shyamnagar, P.S.- Balarampur, Dist- Purulia, 3) Shyamapada Singh Sardar (23 yrs) S/O- Haren Singh Sardar of Vill.- Patcum Chatarma, P.O.- Jugilam, P.S.-Nimdihi, Dist.- Saraikella Kharswan (JKD) along with following seized articles viz-

- 1) 17Ltrs(Approx) of country spirit contained in a container
- 2) 250 grms(Approx) NISHADAL,
- 3) Eleven pieces of Plastic glass
- 4) Sell proceed of Rs. 158/-

I SI Nagendra Nath Das of Balarampur P.S. do here by lodge a complaint against accused persons namely 1) Rathu Singh Sardar (38 yrs) S/O- Paban Singh Sardar, 2) Somchand Soren (23 yrs) S/O- Lt. Kalipada Soren both of Vill.- Barachatarma, P.O.- Shyamnagar, P.S.- Balarampur, Dist- Purulia, 3) Shyamapada Singh Sardar (23 yrs) S/O- Haren Singh Sardar of Vill.- Patcum Chatarma, P.O.- Jugilam, P.S.-Nimdihi, Dist.- Saraikella Kharswan (JKD) to the effect that today (20.03.19) at about 17:15 hrs. in course of my mobile duty I received a telephonic information from a reliable source that accused persons namely 1) Rathu Singh Sardar (38 yrs) S/O- Paban Singh Sardar, 2) Somchand Soren (23 yrs) S/O- Lt. Kalipada Soren both of Vill.- Barachatarma, P.O.- Shyamnagar, P.S.- Balarampur, Dist- Purulia, 3) Shyamapada Singh Sardar (23 yrs) S/O- Haren Singh Sardar of Vill.- Patcum Chatarma, P.O.- Jugilam, P.S.-Nimdihi, Dist.- Saraikella Kharswan (JKD) stocked country spirit illegally and selling the same to hike price for his personal gain then I informed the matter to O/C Balarampur PS and as per order of O/C Balarampur PS myself along with force rushed to the spot for raid by Govt vehicle . At about 17:45 hrs myself along with force reached beside a pond at Jungle area of Barachatarma village and held raid and found that the accused persons were mixing the country spirit, contained in 20 Ltr. Container, with some intoxicated substance (like white powder) having acrid smell which is likely to cause disability or death to human being, beside the pond at Jungle area of Barachatarma village and seeing the police party some person fled away but police party anyhow managed to apprehend above noted 03 (three) accused persons and detained them. I asked them about the white powder like substance and accordingly, detained accused persons recognized it as "NISHADAL"(approx 250 gms contained in a plastic) an intoxicated substance having acrid smell which is likely to cause disability or death to human being. Noted that during interrogation it came to know that Shyamada Singh Sardar came at Barachatarma village to sale the NISHADAL. So I arrested the above mentioned accused persons maintaining all guidelines of the Apex Court of India & NHRC regarding arrest and seized the above mentioned articles after preparing proper seizure list duly signed by accd. persons and available witnesses.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested accused persons namely 1) Rathu Singh Sardar (38 yrs) S/O- Paban Singh Sardar, 2) Somchand Soren (23 yrs) S/O- Lt. Kalipada Soren both of Vill.- Barachatarma, P.O.- Shyamnagar, P.S.- Balarampur, Dist- Purulia, 3) Shyamapada Singh Sardar (23 yrs) S/O- Haren Singh Sardar of Vill.- Patcum Chatarma, P.O.- Jugilam, P.S.-Nimdihi, Dist.- Saraikella Kharswan (JKD) and arrange for its investigation.
