Sir,

In producing herewith the arrested accused persons (1) Sahan Mudi (55 Yrs) S/o- Lt. Ramchand Mudi of Village- Palashdih tola Mudidih, PS- Boram, Dist- East Singbhum, Jharkhand (2) Dilip Mudi (28 Yrs) S/o- Lt. Santosh Mudi Village- Ramnagar (Sonaijuri), PS- Purulia (M), Dist- Purulia along with seized recovered articles approx 20 liters of I.D liquor with in rubber bladder. I beg to submit that on 10.03.2019 at 14.15 hrs I got a source information while I was on mobile duty that two persons may came to Barabazar Bus Stand side along with I.D liquor. Accordingly I inform the matter to I.C Barabazar PS and as per his direction diarized the matter vide GDE No- 435 Dtd. 10.03.2019.

Accordingly myself along force C/- 1228 Babulal Hansda & C/- 346 Shaktipada Rajak left for Barabazar Bus Stand area with govt. vehicle having No- WB 56C 0014. At around 14.35 hrs reached at near Barabazar Bus Stand and placed ourselves accordingly. After sometime around 14.55 hrs source indicated that, the persons approaching towards Bus Stand. As soon as they reached at Barabazar to Sindri Pitch Road near Bus Stand we apprehended them and encircled that.

I disclosed my identity to them & requested their identity. After a little pause they disclosed their identity as noted above. I inform them the cause of detention and requested them if they want they can search us. But they declined. I search them and found one rubber made bladder (Tube) having handle. One side was in the hand of accused Sahan Mudi and other side was in the hand of accused Dilip Mudi. It was defected that the liquid in side is having pungent smell & it appears as I.D liquor.

Accordingly, I seized the whole articles i.e. 20 liters under proper seizure list and marked as Exhibit-A; from the total materials I kept approx 01 liter as sample and mark as Exhibit-A1. The seizure list was prepared at P.O and duly signed by detained persons and witnesses. As they failed to produce any documents, I arrested them at 15.55 and 16.05 hrs by issuing memo of arrest. I sealed and labeled the bottle. Then myself alongwith force, seized articles and all relevant papers and accused persons left for PS.

On arrival at PS I prepared this letter of complaint and handed over everything to I.C Barabazar through Duty officer for starting a case under proper section of law against the accused persons (1) Sahan Mudi (55 Yrs) S/o- Lt. Ramchand Mudi of Village- Palashdih tola Mudidih, PS- Boram, Dist- East Singbhum, Jharkhand (2) Dilip Mudi (28 Yrs) S/o- Lt. Santosh Mudi Village- Ramnagar (Sonaijuri), PS- Purulia (M), Dist- Purulia for illegal trading of I.D liquor.
