I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act-2007 , to the effect that GULZAR ANSARY S/O LT. RASUL ANSARY of Vill- LAGUDIHI, P.S- Barabazar , Dist- Purulia was enjoying electricity illegally hooking from nearest LT OH line with the help of two core service cable and he has committed theft of electricity U/S 135(1)/A of the electricity (Amendment act-2007).

On 13.03.2019, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) SAHEB SUTRADHAR, S.A.E(E), BARABAZAR CCC, WBSEDCL
- (2) MD QASIM ANSARI, O.E., BARABAZAR CCC, WBSEDCL

At About 04:45 P.M., entered into the premises of GULZAR ANSARY S/O LT. RASUL ANSARY of Vill- LAGUDIHI, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill.- LAGUDIHI, P.S Barabazar, DIST- Purulia.

During inspection, it was found that GULZAR ANSARY S/O LT. RASUL ANSARY of Vill- LAGUDIHI, P.S- Barabazar, Dist.- Purulia was enjoying electricity illegally hooking from nearest LT OH line with the help of two core service cable in his premises at LAGUDIHI having connected load 0.117 KVA.

From the above arrangement he was using the following arrangements:

02. 2 core service cable (14 Mtr. App.) along with hooking arrangements.
