**Sub:** Prayer for starting a specific case against Krittibas Bauri (49 Yrs) S/o- Lt. Khandu Bauri of Village- Bhagabandh, PS- Barabazar, Dist- Purulia.

Sir,

In producing herewith the arrested accused persons (1) Krittibas Bauri (49 Yrs) S/o- Lt. Khandu Bauri of Village- Bhagabandh, PS- Barabazar, Dist- Purulia, along with seized recovered articles approx 28 liters of I.D liquor with in rubber bladder. I beg to submit that on 23.03.2019 at 04.15 hrs I got a source information while I was on mobile duty that one person may came to Rautora More along with I.D liquor. Accordingly I inform the matter to I.C Barabazar PS and as per his direction in course of my night mobile duty myself left for that place. I am to note that, I was carrying investigation tools as a routine work including my laptop.

Accordingly, myself along force C/- 1130 Asik Aksari & C/- 185 Rajesh Roy left for Rautora More area with govt. vehicle having No- WB 56C 0014. At around 04.45 hrs reached at near Rautora More and placed ourselves accordingly. After sometime around 04.55 hrs source indicated that, the person approaching towards Rautora More. As soon as he reached at Rautora More we apprehended him and encircled that.

I disclosed my identity to him & requested his identity. After a little pause he disclosed his identity as noted above. I inform him the cause of detention and requested him if he want he can search us. But he declined. I search him and found one rubber made bladder (Tube) having handle which was in the hand of accused noted above. It was detected that the liquid in side is having pungent smell & it appears as I.D liquor.

Accordingly, I seized the whole articles i.e. 28 liters under proper seizure list and marked as Exhibit- A; from the total materials I kept approx 01 liter as sample and mark as Exhibit- A1. The seizure list was prepared at P.O and duly signed by detained persons and witnesses. As they failed to produce any documents, I arrested them at 05.30 hrs by issuing memo of arrest. The process of seizure executed in between 05.00 hr and 05.25 hrs including sampling and labeling. I sealed and labeled the bottle. Then myself along with force, seized articles and all relevant papers and accused persons left for PS.

On arrival at PS around 05.55 hrs I prepared this letter of complaint and handed over everything to I.C Barabazar through Duty officer for starting a case under proper section of law against the accused persons Krittibas Bauri (49 Yrs) S/o- Lt. Khandu Bauri of Village- Bhagabandh, PS- Barabazar, Dist- Purulia for illegal trading i.e. imports, exports, transports, possesses or sells spirit or intoxicating drug like I.D liquor.
