Dear Sir,

I do hereby lodge a complaint empowered by enabling the electricity act 2003 subsequently Electricity (Amendment) Act - 2007 to the effect that Sri ~~Baske~~ ~~Sri~~ Rampada Baske (user) s/o Lt Chului Baske, reside at vill - Manikdih, P.O - Kumari, PS - Boro Dist - Purulia has committed theft of electricity u/s 135(1)(b) of the Electricity (Amendment) Act 2007.

It is mention that service connection effected against Chului Baske, father of Sri Rampada Baske having Consumer ID - 242159942, Meter NO - L4619857.

On dated 15.03.2019 at about 06:00 PM, I Sri Swarup Mandal AE & SM Mambazar CCC, WBSEDCL along with Sri Mrityunjay Mandal, Sri SAE (E) Mambazar CCC and Sri Santu Dhali, SAE (B) Mambazar CCC entered the premises of Sri Rampada Baske reside at vill - Manikdih, P.O - Kumari, P.S - Boro, Dist - Purulia and inspected his premises and found that he was enjoying electricity unauthorisely i.e. by passing of energy meter by cutting incomming service cable.

During inspection theft of electricity was found i.e. he was using electricity unauthorisely u/s 135(1)(b) was detected. It was also found that he was using the following electric equipment.

- ① One no 100 watt bulb
 - ② Two nos 20 watt CFL lamp
- out of which we seized the following
- ① One no 100 watt bulb
 - ② PVC service cable 1.5 ft.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 06:25 PM on dated 15.03.2019. the accused person has committed an offence u/s 135(1)(b) of the Electricity Act 2003 (Amendment) Act 2007.

The service connection has been disconnected on 15.03.2019.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule
