Golok Behari Mandal of Vill- Ankro, PO- Ankro, PS - Boro, Dist - Purulia with seizure of approx 40 liters illicit spirit, containing in 04 (Four) ten liters white Zariken from the possession of above noted accused which were seized under proper seizure list.

I beg to submit that today (29.03.19) during my evening mobile duty in 18:45 hrs to 19:15 hrs on acting secret source information I apprehended the above noted person at Ankro at his house and found that above noted ID Liquor which was kept in his house. On interrogation he disclosed his name and address as noted above. On demand he failed to produced any valid documents / License in r/o said illicit spirit which were kept in his house containing approx 40 ltrs illicit spirit, in 04 (Four) ten liters white Zariken. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith. As such he was arrested at 19:15 hrs u/s 67 B.E. Act and during arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor 1000 ml taken out in a separate container as sample with sealed & labeled.
