In producing here with two arrested accused persons namely (i) Rabin Gorain (Approx 35 Yrs) S/O-Lt.Gujra Gorain of Jhalda Station Road Ward No.-04, P.S- Jhalda, Dist-Purulia (ii) Tukai Tewari (Approx 19 Yrs) S/O Lt. Sujit Tewari of Jhalda Kumarkuli Ward No.-10, P.S- Jhalda, Dist-Purulia and brought under arrest with seized articles i.e. (i) 21 (Twenty One) Pcs sealed bottles of Phenerex Cough Syrup @ 110 Rs./bottle, having 100 ml in each bottle (ii) 10 strip of "Alprazolam" Tablets having 10 in each strip (iii) One "Hero Splendor Pro" motor cycle having no registration no, Engine No, Chassis No tampered. Which were found from the possession.

I do here by lodged a written complaint against the above noted accused persons to the effect that on 01/03/19 at 05:05 hrs while performing night mobile duty along with ASI Mohan Samanta and force (C/497-Ambuj Kr. Mondal, C/538-Dayamoy Mahato with Govt. vehicle, vide CC No-561/19, Dtd. 28.02.19) received a telephonic source information that 02 (two) persons are coming from Tulin side to Jhalda Birsha More on Ranchi-Purulia road by a motorcycle with huge quantities of drugs with them. After received such type of information I informed the matter to I/C Jhalda PS and as per his kind instruction myself along with ASI Mohan Samanta and force rushed to Birsha More on Ranchi Purulia road and placed a NAKA. We wait for few times and at 05:25 hrs we found two persons coming from Tulin side and going towards Jhalda town. We intercepted them near at Birsha More and on being asked they disclosed their identity as noted above. On being searched we found the two accd persons were carrying a carton on a "Hero Splendor Pro" motor cycle (having no registration number, Engine number, Chassis number tampered) loaded with (i) 21 (Twenty One) Pcs. sealed bottles of "Phenerex Cough Syrup" @ 110 Rs./bottle, having 100 ml in each bottle (ii) 10 (Ten) strip of "Alprazolam" Tablets having 10 tablets in each strip. On demand they failed to produce any valid documents/ licence in respect of keeping the said drugs. So I seized the same from their possession under proper seizure list duly signed by the Police witnesses as there was no other local witnesses available right that moment and as well signed by the apprehended persons and also prepared label with seal one bottle of "Phenerex Cough Syrup" and one strip of "Alprazolam" Tablets as sample. I arrested the two accused persons for violating the sec. 27 of drugs & cosmetics Act 1940 after maintaining all formalities and also inform them the ground of arrest.

I therefore pray before you to start a case against the above noted arrested two accused persons namely (i) Rabin Gorain (Approx 35 Yrs) S/O Lt.Gujra Gorain of Jhalda Station Road Ward No.-04, P.S- Jhalda, Dist.- Purulia (ii) Tukai Tewari (Approx 19 Yrs) S/O Lt. Sujit Tewari of Jhalda Kumarkuli Ward No.-10, P.S- Jhalda, Dist.- Purulia as per law and arranged for its investigation.
