Sir,

In Producing here with one arrested aced. Person namely Nitai Mahato (54 Yrs.) S/O Lt. Jadu Mahato of Village- Buribir, P.S. Jhalda, Dist- Purulia brought under arrest with seized article 01 plastic Jarican containing approx 15 (fifteen) ltrs. Of ID liquor and sealed 25 Bottles C/S (Dilkhus) from his possession. I do hereby lodged this written complain to the effect that on-11/03/2019 at 17:15 hrs. I received telephonic source information that one person selling (ID liquor) at Buribir more beside Tulin Darpa road. I inform the matter to I/C Jhalda P.S over Phone as per his direction myself along with H.G/1681 - Manmatha Kumar, NVF/879- Tapan Mahato vide C.C No. 670/19 Dtd- 11/03/19 left for Buribir more to work out the information. We reached at Buribir more at about 18:15 Hours and held raid in the food shop of Nitai Mahato and found that the person selling ID liquor and country sprit (Dilkhus) in his food Shop. I asked him for valid documents of the selling this illicit liquor. He failed to produce any valid documents in respect of said ID liquor and C/S. Accordingly I seized one plastic Jarican containing approx 15 (fifteen) ltrs. of ID liquor and 25 sealed Bottles C/S (Dilkhus) under proper seizure list duly signed by the witnesses as well as accused person with proper label. I search for local witnesses but none is there.

So, I arrested him on interrogation he admitted his guilt. The arrest and seizure was made 18.25 hrs. to 18:45 hrs. with maintaining all formalities. On integration he confessed that he selling the said ID liquor to the villagers in lieu of money.

On return to P.S. along with aced. person and all seized articles. Put the aced. Person in the Lockup after maintaining all formalities and seized articles kept in P.S. Malkhana and I submitted written complaint before I/C Jhalda P.S. to start a case against Nitai Mahato (54 Yrs.) S/O Lt. Jadu Mahato of Village- Buribir, P.S. Jhalda, Dist. Purulia under proper section of law.
