Sir,

In producing herewith the arrested accused person namely Manoj Roy S/O Kishore Roy of Vill- Pat Jhalda, PS - Jhalda, Dist - Purulia along with seized articles 1) One country made improvised pipe gun, 2) One round live .8 mm ammunition to the fact that today (11.03.19) at 17:15 hrs. while I was engaged in special raid duty, received credible source information that one person namely Manoj Roy, aged about 30 years, being equipped with fire arms, moving around Purulia Gola road near Kanshra Jungle under Jhalda P.S. with ill motive. I also took descriptions of the person and his wearing apparels (Black colour full sleeve ganji and navy blue jeans pant). Accordingly I informed the matter to I/C Jhalda PS and noted in GDE vide GDE No- 471 Dt- 11/03/19 and as per his direction I I.SI- Arpita Das and force namely C/1376- Tapan Das and NVF/933- Abani Kumar left P.S. to work out the information vide C.C. No. 671 Dtd- 11/03/19. On way I briefed my accompanied staff about the description of the suspect Manoj Roy and the mode of action to be done during detention. At 17:35 hrs. we reached near Purulia Gola road near Kanshra Jungle area and kept the Govt. vehicle 200 meters away from Kanshra Jungle and ambushed ourselves in a dark side area. After few minutes, according to the source information, we intercepted one person as described above, disclosing our identity.

On being asked the person disclosed his name and address as Manoj Roy S/O Kishore Roy of Vill- Pat Jhalda, PS - Jhalda, Dist - Purulia. On being searched of his person one country made improvised pipe gun loaded with one round live .8 mm ammunition recovered from his left waist. On demand he failed to produce any valid document in respect of possession of arms and ammunition. He also failed give any satisfactory answer about the possession of Arms and Ammunition. As such for committing an offence punishable U/S 25(1)(B)(a) Arms Act. Hence, I arrested him issuing arrest memo, informed ground of arrest and other guidelines regarding arrest. Then, I seized one country made improvised pipe gun and one round live .8 mm ammunition from his possession under proper seizure list duly signed by the above noted accused person and police witnesses. No public witnesses were available there at P.O. at that time.

I therefore pray before your that kindly start a case as per law and arrange its investigation.
