Sir,

In producing herewith one arrested accused person namely Bikram Sardar @ Burka (32) S/o-Late Badal Sardar of Vill-Garh Joypur, PS-Joypur, Dist-Purulia, State-WB under arrest along with seized articles as per seizer list i.e. 17 (Seventeen) bottles Illicit country spirit "DILKHUSH" strength 80 up measuring 600 ML each bottles of Rs. 35/- out of which one bottle taken as sample under proper seizure with label.

I SI Atanu Chakarborty of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that today (11/03/2019) at about 00:15 hrs when myself along with C/89 Shaktipada Shaw, C/-969 Niranjan Mahato, NVF/-018 Biswanath Mahato were performed night mobile duty vide CC No-507/19 dt-10/03/19, received a source information I reached at Atakol more under Joypur PS and found that the above noted accused person selling country spirit "DILKHUSH" in his shop near Atakol more. On seeing Police persons he conceal his presence at that shop. On demand he failed to produce any valid documents in respect of selling such ID Liquor. On interrogation he disclosed his name and address as noted above. He also stated that he have collected the said ID liquor from Jharkhand side for selling the same to the local people illegally at Atakol More in his shop under Joypur PS. So I seized the same under proper seizure list & label duly signed by him and other available witness after taking 01 litters of ID liquor as sample out of 17 litters of ID liquor. During further interrogation he confessed his guilt as such I arrested him today 11/03/2019 at 00:25 hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Bikram Sardar @ Burka (32) S/o-Late Badal Sardar of Vill-Garh Joypur, PS-Joypur, Dist-Purulia, State-WB u/s-46A (c) of the Bengal Excise Act 1909.
