In producing herewith the arrested accused person namely Suresh Gorain s/o- Karmu Gorain of Vill- Jala, P.O- Ghetiali, PS- Pindrajora, Dist- Bokaro (JH) along with seized articles viz. (i)) One plastic jarican, containing 25 ltrs (approx) of Country Spirit and (ii) three Pcs. plastic glasses, the fact in brief is that I ASI Joydeb Gorai of Baglata I/C, under Joypur PS, Dist- Purulia received a credible source information today i.e. on 11/03/19 at around 19.25 hrs. in course of my evening mobile duty at Baglata I/C area that one person namely Suresh Gorain s/o- Karmu Gorain of Vill- Jala, P.O-Ghetiali, PS- Pindrajora, Dist- Bokaro (J.K) is selling country spirit illegally and stored huge quantity of country sprit in an open field which Situated at Kashipur village. Accordingly, I along with accompanying available force had been to the said place to work out the source information after obtaining kind permission from O/C Baglata I/C. At around 20.05 hrs, keeping our vehicle in a safe distance when we proceeded on Spot and found that the information is true. On seeing police personal, the accused person namely Suresh Gorain tried to flee away from the spot, however we manage to nab him after a hot chase. Accordingly, I asked him to produce valid license in respect of selling & stocking Country Spirit but he failed though sufficient time was given. During search and verification, the above noted articles have been seized from the spot after preparing proper seizure list in presence of witnesses namely C/530 Sankar Mahato, C/522 Ruplal Tudu both of Baglata I/C, P.S-Joypur, Dist. Pruulia as public witnesses were not available at that time. I collect 01(one) Ltr. I.D liquor as sample and labeled properly.

Under the above fact and circumstances, I pray before your good self that a specific case under proper section of law may kindly be started against the arrested accused person Suresh Gorain s/o- Karmu Gorain of Vill- Jala, P.O- Ghetiali, PS- Pindrajora, Dist- Bokaro (JH) for its investigation.
