In producing herewith one arrested accused person namely Gurupada Rajak (45) S/o-Late Bhagirath Rajak of Joypur Chatipara, PS-Joypur, Dist-Purulia, State-WB under arrest along with seized articles as per seizer list i.e. 19 (Nineteen) bottles Illicit country spirit "DILKHUSH" strength 80 up measuring 600 ML each bottles of Rs. 35/- out of which one bottle taken as sample under proper seizure with label.

I SI Abhijit Singha of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today (19/03/2019) at about 20:15 hrs when myself along with C/-456 Gopal Kaibartya, C/-280 Ajit Das were performed special mobile duty, as per my source information I reached at Joypur Chatipara on Barabendya morum road under Joypur PS and found that the above noted accused person selling country spirit "DILKHUSH" in his shop at his house. On seeing Police persons he conceal his presence at that shop, but on searching we able to trace out him and also to found that 19 (Nineteen) bottles of Illicit country spirit "DILKHUSH" which was kept conceal in a bag in his shop. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Id liquor to the local people in his shop Chatipara on Barabendya morum road after collecting from Jharkhand side but on demand he failed to produce any valid documents in respect of selling such ID Liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list & label duly signed by him and other available witness after taking 01 bottles of ID liquor as sample out of 19 bottles of ID liquor. During further interrogation he confessed his guilt as such I arrested him today 19/03/2019 at 20:25 hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Gurupada Rajak (45) S/o-Late Bhagirath Rajak of Joypur Chatipara, PS-Joypur, Dist-Purulia, State-WB u/s-46A (c) of the Bengal Excise Act 1909.
