Sub: Complaint against arrested accused person namely Md. Eklakh Chaudhury @ Bhutchowa Chaudhury @ Chutua (30yrs) S/O Tahid Chaudhury of vill. Karkara, P.S. Joypur, Dist Purulia to start a cog case U/S 411/414 IPC & Sec. 25(1)(a) Arms Act.

Sir,

In producing here with the arrested accused person namely Md. Eklakh Chaudhury @ Bhutchowa Chaudhury @ Chutua (30yrs) S/O Tahid Chaudhury of vill. Karkara, P.S. Joypur, Dist Purulia, along with seized articles as per seizure list i.e. one improvised country made fire arms (Iron made) length in total 21 cm (approx) fitted with wooden butt, body, barrel, trigger, firing pin etc and 01 (One) round 8 mm live ammunition, I beg to lodge this complaint against the said arrested accused person to the effect that today I along with ASI622 Joydev Gorai and force (C/530 Sankar Mahato and C/522 Ruplal Tudu) of Baglata I/C were performing Anti Crime Naka duty at Karkara Inter State Border from 19:25 hrs as per schedule which refers to Baglata I/C GDE No. 601/19 Dtd: 23.03.19 & Baglata I/C C.C. No. 475/19 Dtd: 23.03.19. Then at about 21:45 hrs, we found one Motor Cycle which was coming from Jharkhand side tried to fled away in a clandestine manner seeing the Naka Checking Party. Registration Number of said suspected Motor Cycle was not written over the Number Plates both front & back. Accordingly, we react quickly and apprehend the Motor Cycle rider with his Motor Cycle. After that, I asked him why he tried to flee away and using vehicle without Number Plate. Then, he made incoherent statement. I searched him thoroughly on the spot with proper decency and recovered one improvised country made Fire Arms loaded with one round 8 mm live ammunition from his exclusive possession which was kept conceal inside the pant at left side of waist position under the T-Shirt. On demand he failed to produce any valid documents /license as well as satisfactory explanation in respect of keeping such Fire Arms & ammunition. I also asked him to produce relevant papers in respect of the Motor Cycle (Black Coloured LIVO HONDA HET BS-IV), but again he failed to furnish. On interrogation, it is strongly appeared that he is concealing the said Motor Cycle as stolen property as it is procured by means of theft or any fraudulently means and procured the Fire Arms & Ammunition with a view to sell or to commit any crime. He also admitted that he is dealing with such kind of Fire Arms and Ammunition habitually since long. I would like to mention here that he is a habitual offender having past criminal records at Joypur PS (1. Joypur P.S. Case No. 06/01 Dtd: 25.02.01 U/S 25(a)/27 Arms Act and 2. Joypur P.S. Case No. 14/18 Dtd: 22.02.18 U/S 399/402 I.P.C. & Sec. 25/35 Arms Act) as well as at Jharkhand side (Kasmar P.S. Case No. 44/18 Dtd: 10.07.18 U/S 379/411 I.P.C. Hence, I arrest him on the spot after preparing proper Arrest Memo and issued one copy to him. Then, I seized the following articles after preparing proper seizure list, seal & label duly signed by the witnesses-

(i) One improvised iron made country made fire arms fitted with Butt, Body, Barrel, Trigger, Firing Pin, having overall length of approx 21 cm (approx), Butt to Body 13 cm (approx) and Barrel 13.5 cm(approx) which recovered & seized from the exclusive possession of accused Md. Eklakh Chaudhury @ Bhutchowa Chaudhury @ Chutua found kept conceal inside the pant at left side of waist position under the T-Shirt.

(ii) One round 8 mm cartridge has been recovered and seized after unloading from above noted seized Fire Arms.

(iii) One Black Coloured LIVO HONDA HET BS-IV Motor Cycle having Engine No. JC71E-T-3032874 & Chassis No. ME4JC718DJT011407.

I like to mention here that no public witnesses were available at that time due to odd hours of night.

Hence, I request you to start a cog case against the arrested accused person namely Md. Eklakh Chaudhury @ Bhutchowa Chaudhury @ Chutua S/O Tahid Chaudhury of vill. Karkara, P.S. Joypur, Dist Purulia u/s- U/S 411/414 IPC & Sec. 25(1)(a) Arms Act and arrange for its investigation.
