In producing herewith arrested accused namely Sanjoy Chowdhury (35 yrs), S/O Chandra Chowdhury of vill - Kalidaha, PS - Kashipur, Dist- Purulia along with seized articles, I beg to report that on 11.03.19 in course of mobile duty myself along with force got reliable source information that one person is selling ID Liquor at village Kalidaha in his house under Kashipur PS. To work out the information I S.I. Santosh Mandal along with C/365 Chandi Charan Pandey, C/1315 Rajesh Kachhari, reached at Kalidaha village at about 19:35 hrs and found that one person was selling ID Liquor in his house. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling ID liquor in his possession. So the above noted accused has committed an offence u/s - 46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1) 18 (Eighteen) Liter of ID Liquor containing in two Jarikin (Galon) of "Cholai" (2) 08 (Eight) piece of Plastic Glass, accordingly I seized the above noted articles under proper seizure list duly signed by the witnesses in between 19:45 hrs. to 19:55 hrs.
