I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Rathilal Kumar, S/O-Pandu Kumar of village- Chamchaka, P.S- Kotshila, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 08.03.2019 at about 05.30 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato, Gr1 TSH, Joypur CCC 02.Shibaram Mahato, HG TSH, Joypur CCC, 03.Sristidhar Mahato, HG.TSH, Joypur CCC, entered the premises of Rathilal Kumar, S/O- Pandu Kumar of village- Chamchaka, P.S- Kotshila, Dist- Purulia and found Rathilal Kumar, S/O-Pandu Kumar was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through black colour Al cable by means direct hooking to his commercial premises (Brick klin) and connected load found 0.3 KW. As Rathilal Kumar, S/O-Pandu Kumar committed theft of electric power.
