On 08.03.2019 at about 06.20 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato, Gr1 TSH, Joypur CCC 02.Shibaram Mahato, HG TSH, Joypur CCC, 03.Sristidhar Mahato, HG.TSH, Joypur CCC, entered the premises of Jitendranath Bauri, S/O-Ranjit Bauri of village-Choto Metala P.S- Kotshila, Dist- Purulia and found Jitendranath Bauri S/O-Ranjit Bauri was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through CU cable white colour by means direct hooking to his commercial premises and connected load found 0.3 KW. As Jitendranath Bauri, S/O-Ranjit Bauri committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of 01.Ganesh Mahato, Gr1 TSH, Joypur CCC 02.Shibaram Mahato, HG TSH, Joypur CCC, 03.Sristidhar Mahato, HG.TSH, Joypur CCC. The inspection team left the premises at 6.40 P.M.
