I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Sitaram Majhi, S/O-Lt. Budhu Majhi of village- Metala, P.S- Kotshila, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 08.03.2019 at about 07.10 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01. Ganesh Mahato, Gr1 TSH, Joypur CCC 02. Shibaram Mahato, HG TSH, Joypur CCC, 03. Sristidhar Mahato, HG TSH, Joypur CCC, entered the premises of Sitaram Majhi, S/O-Lt. Budhu Majhi of village- Metala, P.S- Kotshila, Dist- Purulia and found Sitaram Majhi, S/O-Lt. Budhu Majhi was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through PVC 06 Sq. mm black colour cable by means direct hooking to his house premises and connected load found 0.3 KW. As Sitaram Majhi, S/O-Lt. Budhu Majhi committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of 01. Ganesh Mahato, Gr1 TSH, Joypur CCC 02. Shibaram Mahato, HG TSH, Joypur CCC, 03. Sristidhar Mahato, HG TSH, Joypur CCC. The inspection team left the premises at 07.25 P.M.
