Sub: Complaint against Tulshi Mahato (51 Yrs), S/O- Late Mahadeb Mahato of Vill- Chatambari, PO- Begunkudar PS - Kotshila, Dist - Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested aced. Tulshi Mahato (51 Yrs), S/O- Late Mahadeb Mahato of Vill- Chatambari, PO- Begunkudar PS - Kotshila, Dist - Purulia with seizure of approx 20 liters illicit spirit, from the possession of above noted accused which was seized under proper seizure list.

I beg to submit that today (11.03.19) during Special Drive duty in between 18:25 hrs to 18:55 hrs on acting a secret source information I held raid at the tea Stall of above noted person at Chatambari . He has selling illicit spirit at his Tea stall . I searched at his Tea Stall and found 20 Litters liters illicit spirit which was kept in a jaricane . On interrogation he disclosed his name and address as noted above. On demand he failed to produced any valid documents in respect of illicit spirit which is kept in Jaricale containing approx 20 litters. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith. As such he was arrested at 18.55 hrs u/s 67 B.E. Act and during arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor 1litter taken out in a separate container as sample with sealed & labeled.

The above noted arrested aced Tulshi Mahato (51 Yrs), S/O- Late Mahadeb Mahato of Vill- Chatambari, PO- Begunkudar PS - Kotshila, Dist - Purulia violate section 18(i) B.E. Act. for possession and shelling of intoxicating not obtained from a licensed vendor and in contravention and he Committed offence u/s 46 A ( C) B.E. Act. 1909.

It may note here that during raid (1)C/-631 TulshiDas Satpati , (2) C/ 921 Madhusudhan Baral accompanied me Vide Kotshila P.S C.C No- 788 Dated 11.03.19

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Tulshi Mahato (51 Yrs), S/O- Late Mahadeb Mahato of Vill- Chatambari, PO- Begunkudar PS - Kotshila, Dist - Purulia
