Sir,

In producing here with the accused person Brihaspati Kumar (25 Yrs) S/O- Lt. Dinabondhu Kumar of Belyadih, PS-Kotshila, Dist-Purulia, brought under arrest along with seized articles as per seizure list i.e. one improvised country made fire arms (Iron made) length in total 23.5 cm (Approx) having wooden butt, body, barrel, trigger, firing pin etc and 01 (One) round live ammunition, I ASI Subhendu Sekhar Bera of Kotshila PS do hereby lodged a written complaint against the above noted accused person to the effect that on 11/03/2019 at 20:15 hrs while myself along with C/1236 Sunil Bauri, C/601 Shyamlal Mandi, (Kotshila PS GDE No- 439, dated-11/03/2019 & CC No-787/19) all of Kotshila PS were engaged in Naka checking duty at Tali Center on Purulia – Ranchi pitch Road (SH-4A) and found the above noted person was coming from Jhalda Side via SH-4A towards Kotshila by a red colour TVS Apache Motor Cycle having Reg. No- JH 01Z/ 9129 and on seeing the Naka Checking party he tried to fled away. Immediately the checking team apprehended him at Tali Center Naka Checking Point. I asked him why he tried to flee away. Then he made incoherent statement. I searched him on the spot and found one improvised country made fire arm loaded with one round live ammunition was kept in his left side of the waist concealed under the t-shirt. On demand he was unable to produce any valid documents /license in respect of keeping such arms & ammunition, neither he can give any satisfactory explanation in respect of carrying such arms ammunition. It appeared he possessed those either to sell or to commit any crime. So I seized the said arms and ammunition along with the motorcycle he used to come from Jhalda side, make - Red colour TVS Apache Motor Cycle having Reg No- JH 01Z 9129 with proper seizure list and the seized arms and ammunition packed, sealed and leveled in presence of police witnesses since none found there available to witness the seizure in between 20:35 hrs and 21:25 hrs. Hence I arrested him at 21:35 hrs as he has committed an offence which is punishable U/S – 25/27 of Arms Act.

Hence I pray to start specific case against accused Brihaspati Kumar (25) S/O- Lt. Dinabondhu Kumar of Belyadih, PS-Kotshila, Dist-Purulia u/s- Arms Act.
