Sub: Complaint against Judhistir Sahis (40 Yrs), S/O- Lt. Lalu Sahis of Vill- Guridih, PS - Kotshila, Dist - Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accd. Judhistir Sahis (40 Yrs), S/O- Lt. Lalu Sahis of Vill- Guridih, PS - Kotshila, Dist - Purulia with seizure of approx 20 liters illicit spirit, from the shop of above noted accused which was seized under proper seizure list.

I beg to submit that today (19.03.19) during Special Drive duty in between 14:15 hrs to 14:35 hrs on acting a secret source information I held raid in the shop of above noted person at Guridih village . He has sealing illicit spirit at his Tea stall. I searched his shop and found approx 25 Litters liters illicit spirit which was kept in a jaricane. On interrogation he disclosed his name and address as noted above. On demand he failed to produced any valid documents in respect of illicit spirit which is kept in Jaricale containing approx 25 litters. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith. As such he was arrested at 14.40 hrs u/s 67 B.E. Act and during arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor 1 litter taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Judhistir Sahis (40 Yrs), S/O- Lt. Lalu Sahis of Vill- Guridih, PS - Kotshila, Dist - Purulia violate section 18(i) B.E. Act. for possession and shelling of intoxicating not obtained from a licensed vendor and in contravention and he Committed offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid (1) R/M- 2291 Bikash Thapa , (2) R/M- 2279 Sunil Tamang accompanied me Vide Kotshila P.S C.C No- 862, Dated 19.03.19.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Judhistir Sahis (40 Yrs), S/O- Lt. Lalu Sahis of Vill- Guridih, PS - Kotshila, Dist - Purulia.
