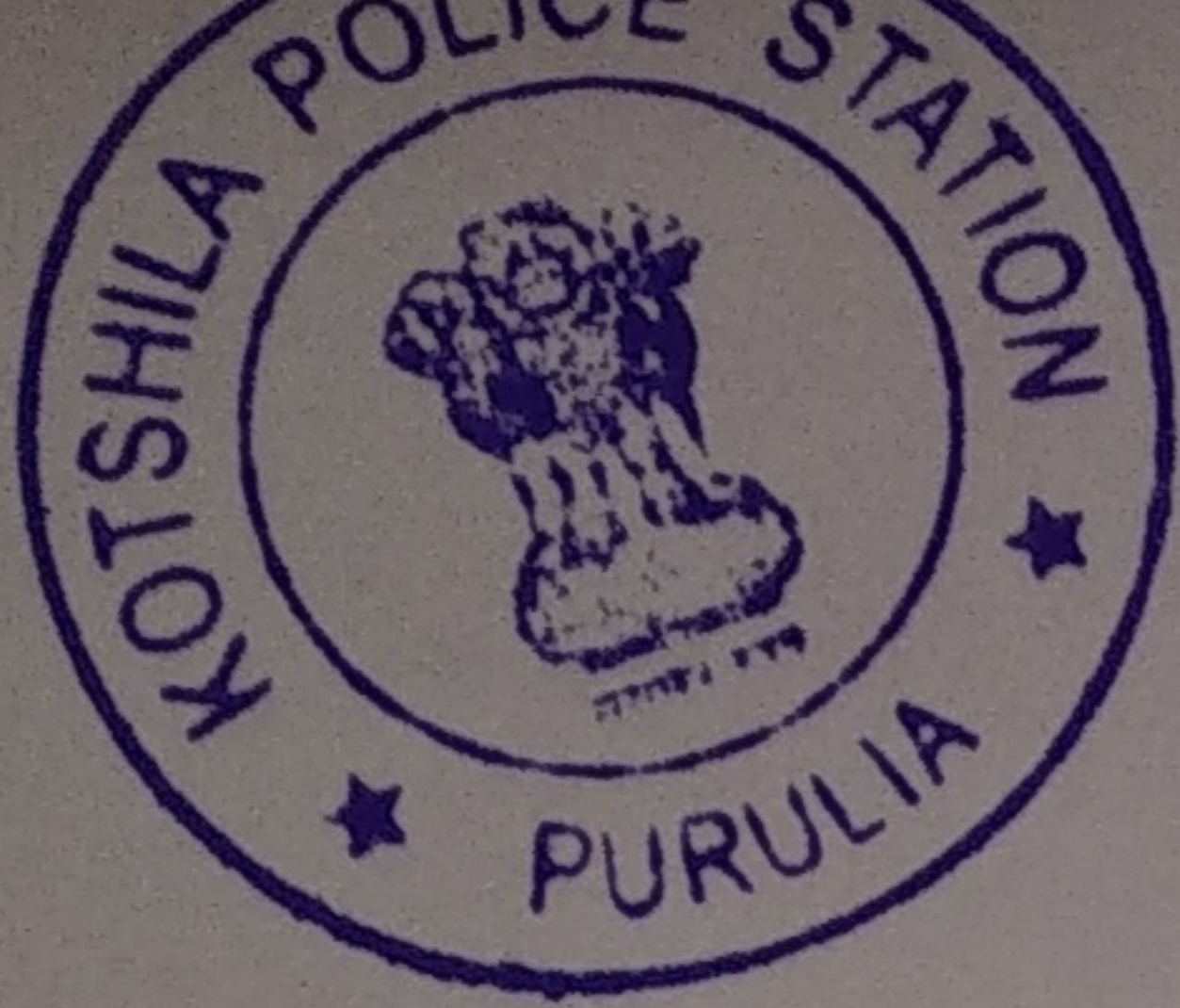
The original typed complaint of the complainant which is treated as F.I.R. is attached here with.

Respected Sir,

In producing herewith one accd. Person namely Kalipada Mahato (51) S/O- Lt. Satrughan Mahato of Chayadih P.S. – Kotshila Dist – Purulia with seizure of 14(Fourteen) sealed bottles of 80 UP Country Spirit “DIL DIAMOND” & each Bottle contains 600 ml. and 16(Sixteen) sealed bottles of 80 UP Country Spirit “DIL DIAMOND” & each Bottle contains 375 ml each which was seized under proper seizure list.

I beg to submit that today (19.03.19) in between 15.05 hrs to 15.45 hrs a raid was conducted in the Gumty Shop of Kalipada Mahato Lt. Satrughan Mahato at Kotshila Bazar near at Kotshila Railway Station under Kotshila P.S. Dist – Purulia. On acting of secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling Country Spirit which was kept in Gumty Shop. On demand he failed to produce any valid documentary authority in respect of selling of liquor from the Shop. As such he was arrested u/s 67 B.E. Act and seized 14(Fourteen) sealed bottles of 80 UP Country Spirit “DIL DIAMOND” & each Bottle contains 600 ml. (14 Bottles x 600 ml= 8.400 Ltrs.) each of Rs-35/ (Total Rs-14x35=Rs-490) and also seized 16(Sixteen) sealed bottles of 80 UP Country Spirit “DIL DIAMOND” & each Bottle contains 375 ml. (16 Bottles x 375 ml= 6.000 Ltrs. ) each of Rs-22/ ( Total Rs-16x22=Rs-352) Total Rs- 842/- and total 80 UP Country Spirit 14.400 ltrs, which was seized under proper seizure list in, u/s 67 B.E. Act which enclosed here with. Out of 14 (Fourteen) sealed bottles one (600 ml) sealed bottle taken out as sample with sealed & labeled and also Out of 16 (Sixteen) sealed bottles one (375 ml) sealed bottle taken out as sample with sealed & labeled. During arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr.P.C and handed a copy of the same to arrest.

The above noted arrested accd. namely Kalipada Mahato S/O- Lt. Satrughan Mahato of Chayadih P.S– Kotshila Dist – Purulia. Committed offence u/s 46A (c) B.E. Act. 1909 for unauthorized possession and sale of country spirit from his Gumti.

It may note here that during raid (1) C/424 Naba Kr. Sao (02) C/1391 Jayanta Panda with accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 A(c) B.E.Act. 1909 may kindly be started against Kalipada Mahato S/O- Lt. Satrughan Mahato of Chayadih P.S. – Kotshila Dist – Purulia.
