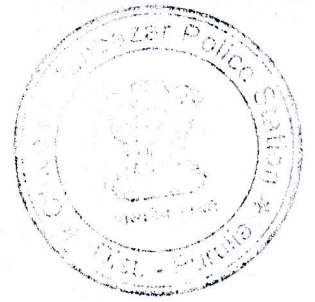

Respected Sir,

In producing herewith arrested accused namely Shyamapada Roy (62 yrs), S/O- Ambuj Kr Roy of vill- Dumuria, PS- Pancha, Dist- Purulia along with seized articles, I beg to report that on 08.03.19 in course of mobile duty myself along with force got reliable source information that one person is selling country liquor at a hotel styled as Roy Hotel at Burisahar on Manbazar Pairachali road Manbazar. Accordingly myself along with C/1183 Subhas Kundu, and C/1316 Ujjwal Mandal both of Manbazar P.S reached at a hotel styled Roy Hotel at Burisahar on Manbazar Pairachali road Manbazar at about 20:15hrs and found that one person was selling C.S. liquor in his hotel styled as Roy Hotel. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling C.S. liquor in his possession. So the above noted accused has committed an offence U/S -46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1)19 (Nineteen) sealed bottles of DILKHUSH C.S. liquor (600 mleach) (2)05(Five) empty bottles of DILKHUSH C.S.(3)05(Five) Plastic Tea Glass (4) Rs. 10/- (One hundred Ten) as sale proceed seized the above noted articles under proper seizure list duly signed by the witnesses in between 20:15 hrs. to 20:35 hrs. I also seized and labeled bottles with sample C.S. liquor at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person U/S-67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with seized above noted articles.

Therefore I pray before you that kindly arrange to start a specific case under proper section of law U/S 46(A)(c) B.E. Act 1909 against arrested Shyamapada Roy (62 yrs), S/O- Ambuj Kr Roy of vill- Dumuria, PS- Pancha, Dist- Purulia arrange for its investigation.
