In producing here with one accused person Dilip Bauri (35) S/O- Lt- Bantu Bauri of village- Madhupur PS- Manbazar, Dist- Purulia along with following seized articles viz-

- 1) 18 (Eighteen Ltrs.) I.D. Liquor within a Jariken
- 2) 05 pieces plastic glass
- 3) Sale proceed of Rs- 125/-

I S.I. Mantu Karar of Manbazar PS do here by lodged a complaint against accused namely Dilip Bauri (35) S/O- Lt- Bantu Bauri of village- Madhupur PS- Manbazar, Dist- Purulia to the effect that today (11.03.19) at 12:45 hrs. I received a telephonic information from a reliable source that one Dilip Bauri (35) S/O- Lt- Bantu Bauri of village- Madhupur PS- Manbazar, Dist- Purulia was stocked I.D. Liquor illegally and selling the same to hike price for his personal gain then I noted this information in GD vide Manbazar PS GDE No- 365 dtd- 11.03.19. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C1429 Jagadish Mahato, NVF- 566 Tapas Mahato rushed to the spot for raid by Govt. vehicle. At about 15:05 hrs. myself along with force reached at Madhupur village and held raid in the house of Dilip Bauri and found that said house keeper selling liquor at his own house and Seeing the police party some persons fled away and said Dilip Bauri tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling I.D. Liquor but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Dilip Bauri (35) S/O- Lt- Bantu Bauri of village- Madhupur PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
