Sir,
In producing here with one accused person Fulchand Mahato (33) S/O Manjora Mahato of village- Nadiha (Gopalnagar) PS. Manbazar, Dist- Purulia along with following seized articles viz-

- 7) 21(Twenty one Ltrs.) I.D. Liquor within a Jariken
- 8) 06 pieces plastic glass
- 9) Sale proceed of Rs- 130/-

I S.I. Mahadeb Rana of Manbazar PS do here by lodged a complaint against accused namely Fulchand Mahato (33) S/O Manjora Mahato of village- Nadiha (Gopalnagar) PS- Manbazar, Dist- Purulia to the effect that today (11.03.19) at 15:55 hrs. I received a telephonic information from a reliable source that one Fulchand Mahato (33) S/O Manjora Mahato of village- Nadiha (Gopalnagar) PS- Manbazar, Dist- Purulia was stocked I.D. Liquor illegally and selling the same to hike price for his personal gain at his hotel styled as Jay Maa Kali hotel at Metala more then I noted this information in GD vide Manbazar PS GDE No- 369 dtd- 11.03.19. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/ 1316 Ujjal Mandal , C/1191 Subodh Hausda rushed to the spot for raid by Govt. vehicle. At about 16:45 hrs. myself along with force reached at Metala more and held raid in the hotel of Fulchand Mahato and found that said person selling liquor at his own hotel Seeing the police party some persons fled away and said Fulchand Mahato tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling I.D. Liquor but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Fulchand Mahato (33) S/O Manjora Mahato of village- Nadiha (Gopalnagar) PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
