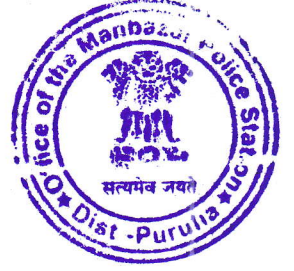

Sir,

In producing here with one accused person Ghaltu Mahato (58) S/O Lt Ankur Mahato of village- Kashidih Majpara, PS- Manbazar, Dist- Purulia along with following seized articles viz-

- (1) 20 (Twenty) bottles (in sealed condition) "DILSE" country spirit, 600 ml. each bottle, total = 12 ltrs. and Rs- 35x20 = value Rs – 700/- (Seven Hundred) only
- (2) 15 pieces plastic glass
- (3) Sale proceed of Rs- 50/-
- (4) 12 pcs. Empty bottle (DILSE) 600 ml. each

I S.I. Mantu Karar of Manbazar PS do here by lodged a complaint against accused namely Ghaltu Mahato (58) S/O Lt Ankur Mahato of village- Kashidih Majpara, PS- Manbazar, Dist- Purulia to the effect that today (15.03.19) at 16:15 hrs. I received a telephonic information from a reliable source that one Ghaltu Mahato (58) S/O Lt Ankur Mahato of village- Kashidih Majpara, PS- Manbazar, Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I noted this information in GD vide Manbazar PS GDE No-599/19 & C.C. No- 703 dtd- 15.03.19. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/1183 Subhash Kundu, C/1429 Jagadish Mahato rushed to the spot for raid by Govt. vehicle. at about 16:25 hrs. myself along with force reached at Kashidih Majpara village and held raid in the dwelling house of Ghaltu Mahato and found that said house selling liquor at his own house and Seeing the police party some persons fled away and said Ghaltu Mahato tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Ghaltu Mahato (58) S/O Lt Ankur Mahato of village- Kashidih Majpara, PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
