In producing here with one accused person Basanka Bauri (40) S/O Lt Kalipada Bauri of v Hage- Anandapur ,PS- Manbazar, Dist- Purulia along with following seized articles viz-

- (1) 18 (Eighteen) Ltrs ID liquor within a Jan kan
- (3) 15 pieces plastic glass
- (1) Sale proceed of Rs- 45/-

I A.S.I. Anirudda Chatterjee of Manbazar I S do here by lodged a complaint against accused namely Sasanka Bauri (40) S/O Lt Kal pada Bauri of village- Anandapur ,PS-Manbazar, Dist-Purulia to the effect that today (19.03.19) at 16:35 hrs. I received a telephonic information from a reliable source that one Sasanka Bauri (40) S/O Lt Kalipada Baum of village- Anandapur ,PS- Manbazar, Dist- I urulia was stocked ID liquor illegally and selling the same to hike price for his personal gair then I noted this information in GD vide Manbazar PS GDE No- 701 Dtd 19.03.19. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along wit a C/1252 Sunil Mandal C/1184 Subhendu Many rushed to the spot for raid by Govt. vehicle. At about 17:05 hrs. myself along with force reached at Anandapur village and held raid in the house of Sasanka Bauri and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Sasanka Bauri tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any va id license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Sasanka Bauri (40) S/O Lt Kal pada Bauri of village- Anandapur ,PS-Manbazar, Dist- Purulia as per law and arrange for its investigation.
