
Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Mantu Rajak (35) S/O- Lt. Baleswar Rajak of Vill-Parbelia Hattola, PS- Neturia, Dist-Purulia, beg to state that while myself along with C/1140 Dayamoy Mahato & C/470 Somnath Nag were performing anticrime evening mobile duty vide Neturia PS GDE No-291 Dt. 07.03.19 & CC No- 625/19 Dt. 07.03.19, at about 19:45 hrs received one information that one truck bearing registration No- HR 55W/5078 dashed one Tata Sumo vehicle bearing No- WB 38Q/8666 at in front of Sai temple, Parbelia Hattola (Purulia-Asansol pitch road, SH-5), subsequently the local people obstructed the road there. To work out the information myself along with force had left for Parbelia Hattola near Sai temple. We reached at about 20:05 hrs and after reaching there I found that the road near Parbelia Hattola (Near Sai temple) which runs between Purulia and Barakar (SH-5) had been blocked by above noted person and Pawan Thakur of Parbelia Camp, Prem Singh of Parbelia Hattola, Sikandar Singh of Do, Roshan Ojha of Do, Ajay Ojha of Do, Prasanta of Do, Mithu Singh of Prabelia Railway Crossing, Lali Singh of Parbelia Hattola, Manoj Rabidas of Do, Jogindar Singh of Do, Annu Thakur of Do, Bikash Ojha of Parbelia 8 No., Sailendra Goswami of Parbelia Camp and near about 40/50 others. They blocked the road over the issue of the incident. I talked to them about proper police action as per law but many of them continued shouting & subsequently went to the road also abused us. I have tried to pursue the agitator to withdraw the blockade and help police to disperse the mob as well as discharge lawful duty. It was also found more than 35/45 vehicles loaded with goods and loaded with passengers and drivers including patients etc. from Purulia side and Barakar side were detained there and subjected to enormous sufferings for a long time but the agitators did not pay heed to the police, I again request them to disperse then they assaulted us with fist & blows as well as threatened us. The above accused person with others continued to be with the unlawful assembly, causing unlawful restraint to the vehicles & passerby and thus generated danger & obstruction in state highway and also caused obstruction to police in discharging Govt. duty also their subversive activities endangering public safety and tranquility of the locality. I informed the matter to O/C Neturia PS and also asked for re-enforcement to rescue us. Accordingly re-enforcement has been made and disperse the agitating mob and rescue us.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Mantu Rajak (35) S/O- Lt. Baleswar Rajak of Vill-Parbelia Hattola, PS- Neturia, Dist-Purulia and Pawan Thakur of Parbelia Camp, Prem Singh of Parbelia Hattola, Sikandar Singh of Do, Roshan Ojha of Do, Ajay Ojha of Do, Prasanta of Do, Mithu Singh of Prabelia Railway Crossing, Lali Singh of Parbelia Hattola, Manoj Rabidas of Do, Jogindar Singh of Do, Annu Thakur of Do, Bikash Ojha of Parbelia 8 No., Sailendra Goswami of Parbelia Camp and near about 40/50 others under section 143/186/283/353/341/506 IPC and read with section 18 of the West Bengal Highway Act 1964 and section 9 of M.P.O. Act against the above noted accused persons.
