he has Committed theft of electricity u/s - 135(1)(b) of the IE Act amended

On 15/03/2019 at about 14:15 Hrs I, Sibdas Baul, Station Manager, Saltore
Customer Care Centre alongwith (1) Mr. Jiaur Rahman Mondal, DE & SLP (2) Mr.
Rameshendra Narayan Sinha, SO, SLP (3) from Pranlia Region office (4) Kamai
Sarmal, LM (5) Satya Rajnar, TSH both from Saltore CC had been in
the house of Mafijuddin Arany for inspection. Prior inspection one
notice was served on Mafijuddin Arany duly received by him.

A through inspection was conducted by me assisted by the
Divisional Engineer, SLP unit. During inspection it has been observed
that the said Commr was enjoying electricity unauthorisedly i.e.
By passing the energy meter from incoming Contact and without
registering the energy Commr in the Energy meter. From the
arrangement he was enjoying following equipments:- (1) Electric fan
- 06 nos (2) Freez - 01 no (3) Colom Tv - 01 no (4) water pump - 01 no (5) Induction
Heater - 01 no (6) CFL 08 no (7) Electric Bulb - 02 nos. Total load
found - 2.666 kw. This is a clear theft of electricity and Mafijuddin
is liable for Prosecution u/s - 135(1)(b) of the IE Act 2003 amended on

I handed over to you inspection report, seizure list all in original alongwith seized articles as per seizure list for taking necessary action.


