Respected Sir,

In producing herewith one accd. person namely Rajesh Choudhary (23) S/O-Lt. Lalo Choudhary of vill-Laharpur, PO-Sadipur, PS-Kadergani, Dist- Nowada, Bihar with seizure of 19 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml. each which were seized under proper seizure list.

I beg to submit that today (19.03.19) at 20:15 hrs while myself along with force were performing anticrime mobile duty near Bhamuria more, received source information that one Rajesh Choudhary (23) S/O- Lt. Lalo Choudhary of vill-Laharpur, PO-Sadipur, PS-Kaderganj, Dist-Nowada, Bihar has illegally stocked liquor in his hut (Made by bamboo & palm leaves) at Bhamuria Palash Dhowra under PS- Neturia & selling the same. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to Bhamuria Palash Dhowra to work out the information. At 20.35 hrs after reaching at Bhamuria Palash Dhowra held raid in the hut (Made by bamboo & palm leaves) of Rajesh Choudhary (23) S/O- Lt. Lalo Choudhary of vill-Laharpur, PO-Sadipur, PS-Kaderganj, Dist-Nowada, Bihar and found that the above noted person was keeping / selling liquor which were kept in his hut, on demand Rajesh Choudhary failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also 19 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml. each which were seized under proper seizure list duly signed by the accused person as well as witnesses and 01 bottle of Dil Khush country sprit containing 375 ml seized as sample out of 19 bottles and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Rajesh Choudhary (23) S/O- Lt. Lalo Choudhary of vill-Laharpur, PO-Sadipur, PS-Kadergani, Dist- Nowada, Bihar has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.
