Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one arrested accd. person namely Chandan Pal (25) S/O-Prabodh Pal of Vill- Saltore Kali Mandir, PS-Neturia, District- Purulia with seizure of 42 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml. each which were seized under proper seizure list.

I beg to submit that today (23.03.19) at 18:05 hrs while myself along with force were performing anticrime evening mobile duty at Parbelia Bazar, received source information that one Aloke Maji S/O- Madan Mohan Maji of Vill-Saltore, PS-Neturia, District- Purulia has illegally stocked liquor in his shop at Saltore village under PS- Neturia & selling the same. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceeded to Saltore village to work out the information. At 18.25 hrs after reaching at Saltore village held raid in the shop of Aloke Maji S/O- Madan Mohan Maji of Vill-Saltore, PS-Neturia, District- Purulia and found that one Chandan Pal (25) S/O- Prabodh Pal of Vill- Saltore Kali Mandir, PS-Neturia, District- Purulia was keeping / selling liquor which were kept in the shop of Aloke Maji, on demand Chandan Pal failed to produce any valid documentary authority in respect of selling of liquor. On being asked said Chandan Pal stated that the owner of the shop namely Aloke Maji left shop just a few minutes ago to purchase some goods and he will return back soon. But after spent of 30 minutes, he did not turn up before us.. As such owner of the shop and Chandan Pal committed offence u/s 46 A(c) B.E. Act and Chandan Pal was arrested U/S-67 BE Act and also 42 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml. each which were seized under proper seizure duly signed by the accused person as well as witnesses and 01 bottle of Dil Khush country sprit containing 375 ml seized as sample out of 42 bottles and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Chandan Pal (25) S/O- Prabodh Pal of Vill- Saltore Kali Mandir, PS-Neturia, District- Purulia and owner of the shop namely Aloke Maji S/O- Madan Mohan Maji of Vill-Saltore, PS-Neturia, District- Purulia have committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1) C/1001 Soumendu Das and 2) C/1353 Atanu Ganguly both of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against owner of the shop namely 1) Aloke Maji S/O- Madan Mohan Maji of Vill-Saltore, PS-Neturia, District- Purulia and 2) Chandan Pal (25) S/O- Prabodh Pal of Vill-Saltore Kali Mandir, PS-Neturia, District- Purulia under proper section of law.
