

Purulia would like to bring the following facts to your kind notice that on dated 15-02-2019 at 22:00 hrs along with his friend Borku Singh slo- Ramdas Singh Modak vill Barabazar, Raya Parda was coming from Purulia towards Barabazar. While the motor cycle registration number WB56H7255 appeared in the front of "Karadhe High School". The rider of the motor cycle being the registration number "WB56H7255" lost the control relevance and collision with electrical pole. The rider of the motor cycle was the owner subsequently the rider of the driver of the motor cycle received seriously injured. He referred to "Sadar Hospital Purulia where attending doctor declared him dead.
