Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that SUDARSHAN BAURI, S/O-Late Gorachand Bauri of VILL- Para(Sunri Kuli),P.S.-PARA, Dist- Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 28.02.2019 at about 3:05 PM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with MR Avishek Das, SAE(E), Mr. Manmatha Mahali, Sr. TSH, Mr Bhakti pada Mahato, TSH and Patit Kora, Sr.TSH, Dubra Para CCC, WBSEDCL inspected the premises of SUDARSHAN BAURI, S/O-Late Gorachand Bauri of VILL- Para(Sunri Kuli),P.S.-Para, Dist Purulia WBSEDCL. During inspection it was found that the said SUDARSHAN BAURI, was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 01no 100 watts bulb approx load 0.100 KW for domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 3:10pm.

AS SUDARSHAN BAURI, S/O-Late Gorachand Bauri of VILL- Para(Sunri Kuli), P.S.- Para, Dist- Purulia has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
