On being demand he failed to produce any valid document in respect of keeping and selling of said liquor. As such I seized 20 (twenty) sealed bottles of Country Spirit styled as "DIL Se" each Bottle contains 600 ml in which 01 (One) bottle collected as sample, which was seized & level under proper seizure list in presence of witnesses and duly signed by them as well as above noted arrested accd. person.

The above noted arrested accd. namely Aklu Bauri S/o Lt- Anu Bauri of Village- Kelyahi, PS- Para, District - Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of country spirit in his house.

Under the above fact and circumstance I pray that a case u/s 46 A (c) B.E. Act'1909 may kindly be started against Aklu Bauri S/o Lt- Anu Bauri of Village-Kelyahi, PS- Para, District - Purulia and arrange for its investigation.
