Sir,

In producing herewith one arrested accd. namely Hazera Ali Pathan @ Hazer (33 yrs) s/o- Manir Pathan of Vill- Bonopara, Aguri Band, Punisol, PS- Onda, Dist- Bankura, with Arrest Memo, Inspection Memo and seized articles viz (1) one iron made single bore country made fire arms having length of 22cm (approx) with butt, barrel, firing pin, trigger etc. (2) one live ammunition of under proper seizure list and being labeled properly, I beg to inform you that today (11/03/19) at 19.45 hrs, in course of performing Naka checking duty with ASI Sk. Monsur and force at Darda under Para PS on Jharkhand- West Bengal border, we intercepted one guy who was moving suspiciously there. On searching, we recovered one iron made single bore country made fire arms from his possession. The arms was loaded with a befitted live ammunition. On asked he failed to any license in favour of possessing the same. On interrogation he revealed his identity as Hazera Ali Pathan @ Hazer (33 yrs) s/o- Manir Pathan of Vill- Bonopara, Aguri Band, Punisol, PS- Onda, Dist- Bankura. Accordingly I seized the fire arms and ammunition from his possession under proper seizure list in presence of witnesses. It is to noted that no public witnesses was available during seizure. The seizure was completed at 20.25 hrs. After seizure I arrested him observing all the formalities regarding arrest.

Hence I pray that a specific case may kindly be started against above noted arrested accused person under proper section of law and arrange for its investigation.
