Entered the premises of BISWAPRASAD MAHATO, S.O- Lt Sri Charan Mahato of Village- Lipania , P.O- Lipania , P.S- Para , Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly directly by tapping from incoming side of service cable of energy meter. (Meter No- B4092144) (Con Id- 242097631)

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- ① TV - 1 No (120 watt)
- ② CFL Bulb - 5 Nos (100 watt)
- ③ Fan - 2 Nos (80x2 = 160 watt)

Out of which we seized the following:

- ① Energy meter with tapped service cable (Meter No - B4092144)
