Sir,

I ASI Pushpen Ghosh of Purulia (M) PS do hereby lodged the complaint against the following persons namely 1) Raghunath Pandey S/O Lt. Kiritibhushan Pandey of Chirka 2) Bijoy Mahato @ ^{Bindu} S/O Ashok Mahato of Golbera 3) Bamdeb @ Vikambar Mahato S/O Lt Patal Mahato of Do 4) Pashupati Mahato S/O Jagannath Mahato of Do 5) Giridhari Mahato S/O Mahadeb Mahato of Golbera 6) Sanjit Mahato S/O Rajen Mahato of Do 7) Subhas Mahato of do and 8) Prabhas Mahato S/O Atul Ch. Mahato of Chirka and 100/150 hobs of Goldbera Village and Chirka Village. It is to mention that today (29/03/19) I along with force was performing the Patrolling duty as per my detailment vide Purulia (M) PS GDE No 1328 dated 29/03/19 & CC no 857 dated 29/03/19 with the detailed vehicle bearing registration no WB26C 5298. During my mobile duty, I received a telephonic instruction of duty officer that an accident took place at Imundi more along Purulia- Ranchi Road (NH 32) and two people was injured. Subsequently, I along with force rushed into the spot and I had arrived at the spot 13:25 hrs forthwith and found that one container vehicle bearing no NL02Q 4262 coming from the Ranchi side collided to the abaft of a stationary trailer container vehicle bearing no NL01K 5586 which was stationed near Imundi more leaving the black top of the road and curious peoples were assembled. On arriving at the spot, I arranged to shift one injured person (khalasi) of the vehicle NL02Q 4262 to Deben Mahato Sadar Hospital, Purulia after taking out from the vehicle. But the driver of the vehicle NL02Q 4262 could not be taken out from the vehicle because of entanglement of him as the vehicle NL02Q 4262 ran under the stationary vehicle NL01K 5586. After assessing the complication of deliverance, I communicated quickly for arranging the recovery van as well as gas cutter so that ensnared person could be rescued. During the process, at about 13: 45 hrs 100-150 hobs of Golbera village and chirka village appeared at the spot and they showed agitation under the leadership of) Raghunath Pandey S/O Lt. Kiritibhushan Pandey of Chirka 2) Bijoy Mahato @ S/O Ashok Mahato of Golbera 3) Bamdeb @ Vikambar Mahato S/O Lt Patal Mahato of Do 4) Pashupati Mahato S/O Jagannath Mahato of Do 5) Giridhari Mahato S/O Mahadeb Mahato of Golbera 6) Sanjit Mahato S/O Rajen Mahato of Do 7) Subhas Mahato of do and 8) Prabhas Mahato S/O Atul Ch. Mahato of Chirka on demand that why the ensnared person could not be rescued till that time. I along with other officers and force tried to convince them by elucidating the complication of the entanglement of that person but they paid no heed on our words. Subsequently, after being provoked by those persons noted in the supra, the mob became furious and started to hurl spall, picking up from the Railway track yonder to the spot aiming at police with a view to kill us. Consequently I along with other officer and forces received grievous

injury and the furious mob set fire the Govt. vehicle bearing no WB26C 5298 in a jiff while the driver of our Govt. vehicle along with other articles such as 1) One Compound Slip book containing serial no 36701 to 36725 with concerned T.R Challan of which 36701 to 36720 was issued 2) One my personal diary 3) One barret cap were inside the vehicle. Though the driver of the vehicle managed to escape from the vehicle but he could not save the other Govt. articles from the cinder. Consequently, I communicated for reinforcement of force from headquarters. Later the mischievous mob had fled away after you along with force arrived at the spot. Subsequently, the fire brigade team arrived at the ground zero as per my information and doused the fire of the Govt. vehicle. Later, the ensnared person was shifted him to Purulia Sadar Hospital after rescuing him. I along with other injured police personals admitted at Purulia Sadar Hospital with the help of others.

Ergo, I lodge the complain before you to initiate a specific case against) Raghunath Pandey S/O Lt. Kiritibhushan Pandey of Chirka 2) Bijoy Mahato @ S/O Ashok Mahato of Golbera 3) Bamdeb @ Vikambar Mahato S/O Lt Patal Mahato of Do 4) Pashupati Mahato S/O Jagannath Mahato of Do 5) Giridhari Mahato S/O Mahadeb Mahato of Golbera 6) Sanjit Mahato S/O Rajen Mahato of Do 7) Subhas Mahato of do and 8) Prabhas Mahato S/O Atul Ch. Mahato of Chirka and others 100/150 villagers of Golbera village and Chirka village as they caused grievous hurt to deter from his duty by using criminal force for obstructing public servant to discharge of public function and attempted public servant to commit murder and mischief by fire with intend to cause damage by obstructing the National Highway and arrange for its investigation and sent my Complaint through SI Pranab Adhikary from Deben Mahato Sadar Hospita, Purulia .


