Sub: Unlawful restraint/obstruction created by one Mr. Mohan Kr. Kataruka and his family members at the time of the undersigned entering upon the business premises of M/s Divyajyoti Nursing Home, being a partnership venture between Rajesh Kumar Agrawal(Huf) and Mohan Kumar Kataruka(Huf) -with ulterior motives and in criminal breach of Trust

The undersigned being t an ex employee of Divyajyoti Nursing Home(The Nursing Home) and the authorised representative of one of the partners of the Nursing Home M/S Rajesh Kumar Agrawal(HUF), represented by its KARTA Dr. Rajesh Kumar Agrawal, s/o Late Bhola Ram Agrawal, r/o of Lake Road Bye Lane, Purulia-723101(Dr. Agrawal) lodge this complaint against Dr. Mohan Kr. Kataruka(DR. Kataruka), s/o Late Prahllad Rai Kataruka, his wife and two sons, all residents of Siddarth Diagnostic Building, Uppar Nadiha, Purlia-723102(The Building), on the following facts:

- 1) That both Dr. Agrawal and Dr Kataruka started a Nursing Home in the year 2014 under partnership(AS per Deed of Partnership dt 17.04.14) of their respective HUF entities- under the name and style of **Divyajyoti Nursing Home** at Siddarth Diagnostic Building at Uppar Nadiha at the first and second floor of the building ,being owned by the two sons of Dr. Kataruka viz. Siddarth & Keshav Kataruka.
- 2) That for the purpose of establishing the nursing home and purchase of costly medical and surgical equipments and other assets of the nursing home above and apart the capital infused by the partners loans were taken from other private persons as well.
- 3) That since July, 2015 I was looking after the affairs of the nursing home and during the course of my duty witnessed and exposed several malpractices being committed by Dr Kataruka and his wife (evidence with me) affecting the interest of the patients of the nursing home and earning a bad name to it and thereby impacting the reputation of Dr Agrawal, as well who enjoys tremendous goodwill and reputation in the area. Due to my opposition to this, Dr Kataruka and his wife started problems with me and for their spurious and negative attitude and conduct the operations of the nursing had to be stopped after some time.
- 4) That there after 1, as a representative of Dr Agrawal, used to visit the nursing home regularly for the maintenance and up keeping of the costly equipments and assets of the nursing home

- as Dr Agrawal ,due to his preoccupations could not manage to visit the nursing home as frequently as I could.
- 5) That for the last few months Dr Kataruka and his family members have been unlawfully trying to obstruct my entry to the nursing home, presumably for some ulterior motives and criminal intents in mind. This fact was reported to Dr Agrawal, who took the issue with Dr Kataruka.
- 6) That on 24.02.19 (Sunday) after a gap of about one month I along with Shri Chandi Goshwami and Shri Bablu Malakar both employees of Dr Agrawal while paying a routine visit to the nursing home premises were stopped and restrained to enter by the wife of Dr Kataruka , presumably under the instructions of Dr Kataruka who was hiding in a nearby room and we were prevented from entering the nursing home and directed and forced to go back immediately. We repeatedly reminded her, Dr Kataruka and his son present there- of their wrongdoings and unlawful act —but they were very adamant and furious and threatened us of dire consequences and compelled us to go back.

That Dr Kataruka and his family members- taking advantage of their occupation and continuous presence in the ground floor and third floor of the building committed criminal breach of trust by forcibly restraining and obstructing myself and the other men of Dr Agrawal (mentioned above) to enter the nursing home for having a check and inspection of costly equipments and assets belonging to it of which Dr Agrawal is a equal partner. The undersigned has reasons to believe that said Mohan Kataruka and his family members have misplaced/stealthily sold some of the assets of the nursing home in the interim, for their personal gains and simultaneously & unlawfully utilizing it for personal gains and profits affecting the interest of Dr. Agrawal

Under the present circumstances, I request your good office to restrain Dr Kataruka and his family members from doing such unlawful activities as aforesaid- so that no untoward incidents may take place in future and no loss of or damage to the property belonging to Dr Agrawal is caused. Further, please provide us with appropriate police cover while visiting the Nursing Home in future to avoid any possible breach of peace likely to take place at the site.
