

 That the Complainant is presently residing at her father's house namely Sri Laxman Singh and the house is situated at Kadam Kuli, Gari Khana, Gowala Bandh, P.O- Purulia, P.S- Purulia (T), Dist. – Purulia, within the Jurisdiction of this Ld. Court.






- 2. That the complainant is the legally married wife of Sri Krishna Kumar Dev, S/o-Sri Jivan Kumar Dev, a resident of Vill + P.O- Aarta, P.S- ChandanKeyari, Dist-Bokaro, Jharkhand, and their marriage is still subsisting.
- 3. That the marriage negotiation was held at the parent's house of the complainant at Kadam Kuli, Gari Khana, Gowala Bandh, P.O, P.S & Dist-Purulia, and the marriage was solemnized on 04/12/2017 at the father's house and of the complainant from Brahman Dharmashala as per the Hindu Rights and customs prevail in their society.
- 4. That at the time of marriage the father of the complainant had to give a sum of Rs. 1,00,000/- cash, 5.5 gm of gold ornaments, 60 gm of silver ornaments, utensils, clothes, watch etc as per the demand made by Sri Krishna Kumar Dev and his family members i.e all the accused persons as dowry, as demanded by them.
- 5. That after completion of the marriage the complainant was taken to her matrimonial home on 05.12.2017 at Vill + P.O- Aarta, P.S- ChandanKeyari, Dist-Bokaro, Jharkhand and started their matrimonial life with full hope.
- 6. That from the inception of marriage the complainant was never accepted with love and dignity and she was often teased by her husband namely Sri Krishna Kumar Dev and his family members i.e all the accused persons.
- 7. That after three days i.e on 08.12.2017, the complainant came to her parents house along with her husband and stay for four days. During stay at her parents house the complainant notice that her husband was very reluctant and do not want to talk with anybody, do not want to stay at home and after lapse of four days the accused No. 1 along with the complainant went back to the matrimonial home of the complainant and after reaching there the complainant noticed that the behavior of the accused No. 1 has radically changed and her husband namely Krishna Kumar Dev, her mother-in-law namely Jharna Dev, her aunt-in-law namely Chinta Devi and her sister-in-law namely Bishnupriya, started to abuse the complainant by saying that the dowry given at the time of marriage was inadequate and asked the complainant to bring a sum of Rs. 70,000/- for a motor cycle, a gold chain and a gold ring from her father as additional dowry and when the complainant express





the inability of her father, her husband assaulted the complainant in a brutal manner and the other family members supported him.

- 8. That the complainant had to swallow all such torture and mental pain with the hope that with the passes of time her husband will be changed and happy days will come again and her inmates gave consolation that situation would improve but all the hope was in vain.
- 9. That on 24/12/2018 the complainant was forced to go to her parents house in order to bring cash and other articles as demanded by them and on 12.01.2018 the husband of the complainant came to her parents house to bring her back, but he did not entered into the house of the father of the complainant, and even several request made by her family members, he did not take a glass of water and while returning home in a motor cycle, driven by her husband, she was asked whether she have taken all the articles including cash as demanded by them or not? And when the complainant tried to make him understand that her father is at present not in a position to fulfill the additional demand of dowry, the accused No. 1 started to drive the vehicle in a very high speed and very negligent manner by saying that he will kill the complainant and the cause of death will be reflected as an accident. Under the constraint fear of death the complainant somehow reached to her matrimonial home.
- 10. That after reaching to the matrimonial home of the complainant, her husband disclosed the inability of her father to fulfill their additional demand of dowry and hearing this the in-laws of the complainant started beating her including her husband and since then they started treating the complainant like a maid and used to provide her inadequate food, they also restrained the complainant from entering into the bed room of the accused No. 1.
- 11. That during stay at the matrimonial home of the complainant, she became the eye sore of her husband and his family members and they never accepted the complainant with love and dignity and she was subjected to various means of cruelty in the hands of her in-laws and on 18.02.2018 they again asked the complainant to bring cash of Rs. 70,000/- from her father and when she denied by saying that her father have to take loan for her marriage expenses accordingly it is





not possible for her father to fulfill their demand at that time, then all the above named accused persons assaulted the complainant in a very brutal manner and finally driven out the complainant from the house by keeping all her stridhan, articles, clothes, ornaments and other belonging.

- 12. That thereafter somehow the complainant managed to escape from there along with her father and since then the complainant is residing at her parent's house at Purulia and living like a destitute lady.
 - 13. That after came to the parents house the complainant became ill due to the torture made by her husband and his family members i.e all the accused persons.
 - 14. That after driven out and after came back to the parents house, the complainant had been to Purulia (T) P.S and informed the matter and lodged the complaint but the police of Purulia (T) P.S. refused to accept the same, the reason is best known to them.
 - 15. That seeing no action on the part of Purulia (T) P.S the complainant informed the matter to S.P, Purulia on 30/04/2018 but no action has been taken.
 - 16. That the police authority directed your petitioner / complainant, orally to come through this Ld. Court hence this petition U/s- 156(3) Cr. P.C.

It is therefore prayed that your Honour will be graciously pleased to send this petition to O/C Purulia (T) P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr. P.C. and to investigate the case in accordance with law and to unearth the wrongdoer
